**Probable Cause**

On 7/15/16, at approximately 2330 hrs, I was dispatched to The Keys Residential in reference to damaged property. Upon arrival, I observed the south door and 2 windows adjacent to that door (all glass) of building #4 with significant damage with what appeared to be a small round hole in each of the tempered glass panels. The glass was shattered on all three. The division of housing for The Keys Residential estimated the damage to be over \$1,000. Upon further investigation, I viewed the video surveillance to building #4 and observed two black males with BB guns shooting at someone inside the north door to building #4 at approximately 1845 hours on 7/15/16. Building #4 was an occupied dwelling at the time of this incident. The two males were identified by their ID cards as Rick Anthony Wells, Jr. and Tyrie Cleveland. Post Miranda, Cleveland admitted to shooting into the building

with his BB gun and turned his BB over to me. Tyrie Cleveland was arrested for felony criminal mischief and shooting a missile into a dwelling.
